The West Indies Cricket Umpires' Association (WICUA) in tandem with Cricket West Indies has the responsibility to recruit, train, examine, certify and develop umpires to officiate in cricket matches to the highest levels of the ICC that is Test Match Cricket and other International Cricket Matches.

The WICUA has been involved in preparing and certifying Cricket Umpires in this region since its inception in 1962. It has produced and continues to produce Umpires of the highest calibre that have been umpiring / officiating in local, regional and international cricket matches.

As the umpiring arm of Cricket West Indies, a duly recognized full member of the ICC, it is the authoritative body that administers and ensures that its umpires are properly qualified to officiate in cricket matches at any level of cricket in the world.

Please therefore be advised that our members including those in the USA, Canada and Bermuda have been given the directive to conduct training on our behalf and to administer local examinations to prequalify candidates for the WICUA examinations. The WICUA examination certification is the highest level of cricket umpiring certification that is parallel with other full and associate members of the ICC necessary to officiate in all cricket matches, including international matches.

Please therefore be guided accordingly.
